CIRCULAR

It is proposed to appoint Medical Superintendents for the Hospitals/Institutions under Delhi Government, Medical Superintendents for the Maternal & Child Wing under each hospital having 500 beds and above and Medical Superintendents for Centres for Excellence, that are proposed to be set up in hospitals in future.

The appointment would normally be for probation period of 01 year and the tenure can be extended upto 05 years depending on the performance evaluation during the probation and on annual assessment.

In this regard, applications are invited from the doctors who may be eligible and willing to discharge responsibilities as per application form enclosed.

Eligibility:

- (i) Working in Delhi Govt./Central services.
- (ii) Specialists Non-Teaching, Specialist Teaching and GDMOs with PG Degree qualification and having 15 years Experience after Post Graduation.
- (iii) GDMOs not having PG Degree qualifications having atleast 20 years Experience after graduation.
- (iv) The applicant should not be more than 60 years of age in case of Teaching Specialist as on 01/10/2015
